HCA President's Report for 2018

CLUB STRUCTURE

2018 will be remembered as a year of significant and positive change for the Club's operating structure. Following the 2017 Harvard Club of Australia Strategic Review, 2018 saw all of the ideas and analysis coming to life; "the next era" became the now era. At last year's AGM we thanked Chris Smith and Tom Saar for their massive contributions to the leadership of the Strategic Review. I do so here again. For those members who did not attend a briefing on the review and suggested changes, Tom wrote a very eloquent summary in the 2017 Annual Report.

At the heart of the Strategic Review was seeking ways to facilitate the expansion of our goal, to make a difference as a Harvard community in Australia, for Members, for Harvard and for Australia.

Major amendments to the Constitution were required to implement the enhanced structure. As the Minutes reflect, the new Constitution was overwhelmingly supported by members and passed at the last AGM. Thanks go to Kimberly Everett who led the charge on the updating and rewriting of the Club's Constitution. Kimberly also served on the newly formed Board but has recently chosen to retire from office due a geographic change of work commitments.

Given the importance of values for any organization, especially a volunteer membership organization, the Review refined and codified the HCA Values. At the 2018 meeting we will also acknowledge a member who has been a standout in exemplifying these values.

PHILANTHROPIC ACTIVITY

The Club's contribution to Australia is significantly delivered through our Philanthropic program. Chris Smith leads this activity in his dual roles as Chairman of HCA Philanthropy Pty Limited and VP for Australia of the Club; it is impossible to understate the significance of Chris' contributions to the Club and its philanthropic activity.

During 2018, we awarded 17 scholarships across our 6 programs. This enabled students to attend Harvard, professors to undertake exchanges between Harvard and Australia, educational and non-profit leaders to participate in world leading Harvard programs, Australian Government department leaders to expand their knowledge at the Kennedy School and Club members to attend the Program for Leaders.

The core funding program for the Club's scholarship efforts is the annual Program for Leaders (P4L). Feedback from P4L participants is invariably outstanding. I encourage all members to think about executives and enterprises with whom they are familiar who could benefit from a Harvard Business School professor teaching a short-course in Australia.

FELLOWSHIP ACTIVITY

2018 was a diverse and active year for Club events. It was very pleasing to see a broad array of members involved in leading new events. Event topics were as broad as the geographic spread across the country. We enjoyed hearing from Harvard professors, experienced members, luminaries, leaders and experts. Speakers included Professor Rutkove, Norma Ingram, Jane Halton, Mark Barnaba, Nick Greiner, Jeff Flier, Professor Maratos, Professor Tiesburg, Professor Zreiqat, Amy Smith, Michelle Lipkin, Professor Yermack, Professor Leary, and Professor Pascal.

CLUB MEMBER MENTORING PROGRAM

Under co-convenors Yu Zhang and Susan Overall, our flagship HCA Mentoring Program enjoyed its fourth year and paired a record 18 mentors and mentees across three states. The continued growth and interstate expansion of the program is particularly pleasing. We would like to thank all mentors and mentees for participating, and Zeke Solomon and Allens Linklaters for hosting the launch drinks. The program is looking forward to continuing in 2019 as an opportunity for career development, personal development and fellowship between HCA members of all ages, interests and experiences.

NON-PROFIT FELLOWSHIP LUNCH

The Non-profit Fellowship Awards event is an annual highlight in HCA's calendar. In 2018, nearly 100 Club members and guests gathered at Macquarie Group's global headquarters in Sydney for the luncheon hosted by HCA Nonprofit Chair Lisa George, to meet the 2018 recipients and hear from guest speaker, Scott Farquhar, Co-Founder and Co-CEO, Atlassian.

The Non-Profit Fellowships of A\$12,500 each have been generously supported by Bill and Lea Ferris since their inception in 2001. The fellowships enable two outstanding Australian non-profit CEOs to attend the renowned Harvard Business School course titled "Strategic Perspectives in Non-Profit Management" (SPNM) which is held each year in July. The recipients were Annabelle Daniel CEO Women's Community Shelters and Brendan Cox CEO Legacy Brisbane. Scott Farquhar spoke of Atlassian's Pledge 1% movement, whereby Atlassian donates 1% of profit, product, equity and employee time to charity.

The 2018 selection panel was chaired by Lisa George (former HCA Co-President), and included Club members Patrick Regan (former HCA President), Ben Sebel, Anita Kumar (2012 Non-profit Fellow), and Tony Massaro.

The first in the new format - an evening event at Perpetual Trustees Sydney HQ with post session drinks and food – was held on October 18.

Ted Blamey, Club Life Member and Harvard MBA, led a case discussion in the best HBS tradition. In Leadership Lessons from the American Civil War his stop-action movie excerpts depicted an extraordinary dilemma that faced a newly-promoted young colonel the day before the battle of Gettysburg. Participants identified essential leadership qualities and behaviors that inspired and motivated others to follow.

Philanthropy Report 2018

HCA Philanthropy Pty Limited (HCAP) is the only subsidiary of the Harvard Club of Australia (HCA). HCAP operates leadership programs and acts as joint corporate trustee for the HCA Foundation. This subsidiary was originally established to avoid any financial risk to the Harvard Club of Australia Inc. from operating leadership programs. It has grown to be classified by the ACNC as a medium sized Australian charitable entity. HCAP is a tax-exempt entity, which supports our private ancillary fund - The Harvard Club of Australia Foundation. HCA and HCAP support six scholarship programs to enable transformational educational experiences for Australians. These programs are funded through the generosity of members; from the surplus on our annual Program for Leaders; and from the earnings of endowment funds.

Our Professional Leadership Programs

HCA Philanthropy is now offering four Professional Development Programs in Business Leadership, Non-Profit Leadership, in Public Health Policy and for School Principals. We envisage further leadership programs in the future, including experimentation with a hybrid model of "face to face" tuition combined with webinars, and "on line" courseware.

PROGRAM FOR BUSINESS LEADERS

The 2018 Program for Business Leaders was titled "The Future of Work in the Digital Age". It was taught at the RACV Healesville Country Club near Melbourne by Professors Felix Oberholzer-Gee and Ethan Burnstein. Demand for the Program was strong and was again highly rated by the participants. The speakers in 2018 were Lisa George, HPP'06, Global Head Macquarie Group Foundation, Tim Fung, CEO Airtasker, and Jan Owen, CEO, Foundation for Young Australians.

The 2019 Program for Leaders "Leadership and Culture – DNA for an age of Disruption" will be taught by HBS faculty Professors Joshua Margolis and Ryan Raffaelli from August 4th to August 9th 2019. It is being held for the second time at the RACV resort at Healesville following very strong positive feedback from delegates in 2018. Three guest speakers will share their insights with the participants. They are Rear Admiral Colin Lawrence, Department of Defence, Vivek Bhatia CEO, Australia Pacific -QBE Insurance and Deborah Coakley, EGM Dexus.

PROGRAM FOR NON-PROFIT LEADERS

We also offered another successful 2-day program in May 2018 for non-profit leaders in conjunction with JB Were. Through the use of case studies and interactive sessions, our Leadership Program aims to provide leaders of not-for-profit (NFP) organisations with greater ability to develop and implement strategy, measure impact and drive success. The title was "Developing Strategy and Measuring Impact" it was taught by Professor Kash Rangan, the Malcolm P. McNair Professor of Marketing at the Harvard Business School, and the co-chairman of the school's Social Enterprise Initiative.

The 2019 Program for Non-Profit Leaders will have the same title as the Program for Leaders and will be taught by Professor Joshua Margolis at the RACV Country Club in Healesville from July 31st to August 2nd 2019. The guest speaker will be Karen Mahlab, CEO Pro Bono Australia.

We acknowledge the very significant contribution of Melinda Muth MBA '81, Program Director for the Programs for Leaders and to Suzie Ruse who acted as Program Manager until December 2018.

PROGRAM FOR HEALTH POLICY LEADERS

In June 2019 we welcome Professor John McDonough from the Harvard Graduate School of Public Health to offer 3 seminars in Sydney, Canberra and Melbourne on the topic of Leading Effectively during political change periods. We are working in association with the Deeble Institute for Health Policy Research, the Australian Healthcare and Hospitals Association, and Melbourne University School of Public Health to stage these seminars. This workshop on 'Leading effectively during political change periods' will provide tools and insights to US Health Policy to health leaders in Australia to understand, anticipate and respond to health system challenges in the context of political change, ideological shifts, and health care funding instability in Australia and abroad. Current thinking around value-based health reform will be discussed.

Professor John McDonough is currently Professor of Public Health Practice in the Department of Health Policy and Management, and Director of the Center for Executive and Continuing Professional Education at the Harvard T.H. Chan School of Public Health.

Our thanks to Kirthana Sharma MPH '00 who has demonstrated quiet determination to develop deeper collaboration with the Harvard School of Public Health, and who has been the driving force behind this initiative. We hope to bring further Public Health Policy programs to Australia and build a Special Interest Group of Club Members to support this initiative.

PRINCIPALS CENTRE IN AUSTRALIA – LEADERSHIP FOR SCHOOL EXCELLENCE

For 6 years we have supported scholarships for the Public Education Foundation to send between 3 and 5 outstanding public school principals to a week-long Leadership Program at the Graduate School of Education (GSE). Twenty two principals have won scholarships to Harvard, and upon their return they universally report how important the program has been to their professional development. Most report it as a transformative experience.

As a result of this success, we started discussions in 2017 with the Graduate School of Education to bring this program to Australia. This has resulted in us recently launching the pilot program in Australia to be held at Sydney University from January 13th to 16th 2020. We expect to enroll 150 school principals into this professional leadership development course that is so highly regarded by principals around the world. We aspire to raise donations from members and other benefactors to enable 50 Principals from disadvantaged communities and/or regional and remote parts of Australia to attend this pilot program. Please consider making a tax-deductible donation to the Harvard Club of Australia Foundation. \$5,000 will support one principal, you can also support our "adopt a principal" program. Information on donating is available on the club website under "donate".

Our longer-term vision is to stage this program every year giving the opportunity to 10,000 Principals in Australia and 2,500 in New Zealand. We also seek to have delegates from the Asia Pacific region to give participants the opportunity to learn from other school system leaders. Please engage with school principals that you know to spread the word.

Our thanks to Chris Smith MBA'77 who has tirelessly driven this initiative, and to Ricky Campbell-Allen EdM'10 who has energetically engaged with curriculum design, and who has led the push for enrolments. They are supported by Justina Blackman, our wonderful new Club Administrator and Toni Gallagher as Program Manager.

Members donated \$63,500 during the year, including \$20,000 from Mike Ahrens LLM'62 and \$15,000 from Roger Massy-Greene MBA'79 to support scholarships for the forthcoming Principals Program; \$10,000 from Tony Berg MBA'70 towards the R.G. Menzies Scholarship MBA Fund. Three R.G. Menzies Scholars made donations: \$1,000 from Jessica Roth, \$2,000 from Errol Katz and \$500 from Merrilyn Alt. \$15,000 was received from Luke Woodward and Zeke Solomon towards to Wolfensohn Scholarship. A large number of members added a small donation to their annual subscription which raised an additional \$5,000. An honour roll of donors is shown later in this report.

Australian donors are able to claim a tax deduction for donations to the HCA Foundation managed by Perpetual Trustees, and also for donations to the R.G. Menzies Scholarship fund at the Australian National University. This later fund has a Deductible Gift Recipient item 1 approval, enabling them to accept donations from Private ancillary funds and foundations. HBS alumni in Australia get class and section recognition in the HBS Contributors report for donations made in Australia to HCAF and ANU. Importantly, this is the only way to make an Australian tax deductable donation for your HBS reunion gift. Alumni in the US can donate tax effectively to the R.G. Menzies Fund at Harvard University.

EARNINGS FROM ENDOWMENT FUND

The Club scholarship programs benefit from three endowment funds: The R.G. Menzies Scholarship Fund at ANU, a smaller but similar fund for post graduate study managed by Harvard in the US, and the HCA Foundation – a Private Ancillary Fund.

The ANU endowment has \$1.8 million in the R.G. Menzies general fund and \$355,000 in the MBA specific fund. Annual distributable earnings are about \$80,000 and in addition the capital value of the investment pool is growing at about 5%. The HCA Foundation has an endowment balance of about \$1.4 million. Investment returns in 2018 were 6% income return and 5% capital growth.

The endowment at Harvard produces \$US 44,000 annual contribution to the tuition fee of R.G. Menzies Scholars selected in Australia.

Our Scholarships

2019 HARVARD CLUB R.G. MENZIES SCHOLARSHIPS

The 2019 selection round for the RG Menzies scholarship has now concluded with another two inspirational candidates being selected to pursue their dreams at the Harvard Graduate school of their choice. This number was initially reduced from forty-nine applications to a short list of thirteen, then a final group of six were invited for formal interviews at the Australian National University in Canberra in early April.

The RG Menzies Scholarship is the flagship scholarship program of The Harvard Club of Australia and now marks its 51st year. Founded by Sir James Wolfensohn in 1968, the program has grown steadily in all respects and is recognized as one of the most prestigious post graduate scholarships in Australia, offering two scholarship at USD60,000 each. Over this period the Harvard Club of Australia has supported 88 young men and women with scholarship funding to Harvard. Candidates are reviewed around the overarching objective of their potential to make a significant contribution to Australia and in this context, are then considered under the headings of leadership, intellectual ability and breadth of vision.

There has been quite a lot of change in this last year in the scholarship administration and selection committee. Kimberley Everett who was both a selector and the former RGM HCA Program Leader has retired and we thank her for her generous contributions as a selector and through her leadership. Jon Chambers is the new Program Leader and continues his role as a selector. New HCA selection members this year included Dr Nayana Vootakuru who was a Menzies winner in 2010 and went on to complete a Masters in Public Health and David Niall who was invited to join the selection committee from the Harvard Club of Victoria. We were also pleased to have another Menzies scholar re-join the selection committee from the ANU: Professor Glenn Withers, who was the third scholarship recipient in 1970.



This year's winners are **Dr Alistair Quinn** and **Brigid McManus**. Recognizing that getting to the final interviews is a major accomplishment, when considering the competition, to stand out is special.

Alistair has been accepted to attend the TH Chan School of Public Health where he will complete his Master of Science, specializing in Computational Biology and Quantitative Genetics, commencing this year.

Alistair grew up in regional Queensland and says he always dreamt of becoming a doctor and applying medical insights in the service of his patients. In 2011 he started to focus on Artificial Intelligence (AI), convinced it would reshape healthcare. In 2019 Alistair is now a medical doctor, biomedical scientist and aspiring computational biologist. He has diverse clinical experience, has contributed to two medical start-ups and is currently collaborating on medical AI research at Deakin University.

Alistair says studying his selected course will provide world class training in AI. Selecting the right school was itself a research project. He visited and deeply considered seven universities in the USA, concluding that Harvard represented the best opportunity for him to become immersed among world class researchers and to conduct cutting-edge research.



At Harvard, the course director Prof John Quackenbush has offered to supervise his thesis. Prof Quackenbush was a Harvard Club of Australia Harvard Fellow in 2010 and subsequently spent a period working at QUT in Brisbane. Alistair aims to utilise machine learning to explore gene-networks regulating cancer. This work is deeply relevant to cancer research and a way for him to learn about the application of AI to medical data more generally.

Following completion of his studies, Alistair's short-term goal is to return to Melbourne and collaborate with other scientists and clinicians in a start-up setting to further develop medical AI.

Alistair hopes to build on his current research and create machine learning-enabled tools, supporting doctors to diagnose and treat diseases with extremely high accuracy. He also wants to explore micro RNAs — a blood stream marker with real promise in early cancer detection and to explore targeted immunotherapies which stimulate the immune system to fight cancer

As a longer-term goal, he hopes to help integrate these technologies into our healthcare system and wants to advocate for a start-up accelerator, helping develop Melbourne's Parkville technology precinct into a leading global research hub. He aims to "...lobby government and industry to invest in projects giving research focused clinicians access to world class mentorship and funding".



Brigid will be undertaking a Master of Law at Harvard Law School, with a focus on comparative constitutional law and rights protections.

Brigid's interest in this area and the use of the law to address social disadvantage stems from her early life in a small rural community on the NSW south coast.

Brigid plans to explore the manner in which rights are protected in Australia, in the absence of a formal Bill of Rights, and the role that a rights-based framework can play in addressing disadvantage in access to healthcare and education. She also intends to examine the role that strategic public interest litigation can play in promoting public discussion and debate around Australia's model of rights protections.

After completing her L.L.M., Brigid hopes to gain practical experience in the area of strategic litigation by working for a short period in the US with one of the many esteemed civil liberties organisations then returning to Australia with the aim of working for one of the community organizations developing test case litigation, such as the Public Interest Advocacy Centre.

Drawing on her academic studies and litigation experience, Brigid intends to use her platform to promote strategic litigation while also engaging in policy-based advocacy informed by comparative constitutional analysis. Ultimately, she hopes to be involved in the design and drafting of an Australian Bill of Rights.

Brigid is a solicitor, currently working in commercial litigation in Sydney. She graduated from UNSW with a combined Bachelor of Laws / Bachelor of Social Science. She was ranked first place in both degrees and was awarded the University Medal in Law. Brigid was formerly employed as Tipstaff and Researcher to Justice Beazley, President of the New South Wales Court of Appeal. She has a long history of work in the public interest legal sector, where she has volunteered with organisations such as Redfern Legal Centre and the Sydney Women's Domestic Violence Court Advocacy Service.

The 2018 R.G. Menzies scholars are presently at Harvard. Scott Bolton is studying for a Master of Education (School Leadership). His goal is to return to Australia and help lead a turnaround school in an educationally disadvantaged part of Australia. Simon Dickson is studying for a Master's in Public Policy at the Kennedy School of Government. He is exploring the relationship between the media, politics and public policy, and in particular the role the media can play in fostering cross-cultural and bipartisan dialogue.

2019 Australia- Harvard Fellowships

The Australia Harvard Fellowships were established in 2004 under the leadership of John Turner AMP'86 with the aim of encouraging knowledge exchange between Harvard University and Australian Universities and Research Institutes, consistent with the origins of our R.G. Menzies scholarship program which envisaged Harvard academics visiting Australia, as well as offering post graduate study at Harvard. This program is chaired by Professor Mathew Vadas AO MBBS'70 of the Centenary Institute, and Dr. Galina Kaseko GMP'12 of the Stephen Sanig Research Institute as Program Leader. Since Inception \$1,167,000 has been awarded to 74 Fellowship recipients. This program is highly regarded in life science research circles and has resulted in several substantial National Health and Medical Research Grants, and two Professors migrating to Australia for lengthy periods of research at Australian Medical Research Institutes, and acknowledgement of Hala Zreigat as Woman of the year in NSW in 2018. Hala subsequently addressed the Club at a great Monday Club lunch.

The 2018 selection panel, comprising Professor Mathew Vadas AO MBBS'70, Professor Bob Graham AO (Associate Professor of Medicine '82-'87), Dr. Sue Morey AM MPH'80, Alice Killen MPH'87, supported by Dr. Galina Kaseko GMP'12, met in early December 2018 and selected six new Fellows with an investment of \$81,000, an increase of \$27,000 relative to the prior year:

Recipients will be contributing to the advancement of scientific knowledge and research in Australia, and to the enhancement of links between Harvard University and Australian academic institutions.

The six 2019 Fellows are:



PROFESSOR THOMAS BORTFELD

Prof. Thomas Bortfeld, PhD, a physicist by training, is a Professor at the Harvard Medical School and serves as the Director of the Radiation Biophysics Division at the Massachusetts General Hospital. Dr. Bortfeld has been a primary developer of intensity-modulated radiation therapy (IMRT) and optimized "inverse" treatment planning. He will be visiting The University of Western Australia, The University of Sydney, and The University of Wollongong to educate the staff and students of these institutions on how fundamental physics principles can be deployed to improve cancer treatment, with a view towards initiating research projects in this area.

Prof. Bortfeld will also participate in various conferences and host seminars in his area of expertise.



PROFESSOR BRUCE E. LANDON

Bruce E. Landon is Professor of Health Care Policy and Medicine at Harvard Medical School and a practicing physician at the Beth Israel Deaconess Medical Centre.

Prof. Landon's research focus is on understanding how the structure of the health care system, and of organisations that provide health care, impacts health outcomes.

He will be visiting The Menzies Centre for Health Policy at the Sydney University's School of Public Health to work on strategies to improve the social return on the public health care spending by encouraging higher value services.



VIKRAM KHURANA

Vikram. Khurana is Chief of Division of Movement Disorders at the Brigham and Women's Hospital and Assistant Professor of Neurology at the Harvard Medical School. His work focuses on using models derived from work in genomics and stem-cells to understand differences amongst neurodegenerative disease sufferers (particularly those with Parkinson's Disease), with a view to segmenting those with apparently similar symptoms into distinct groups with shared disease processes.

He will be visiting the Garvan Institute of Medical Research to collaborate on incorporating his research findings into new better clinical trial protocols for Parkinson's Disease.



RACHAEL COAKLEY

Rachael Coakley is a paediatric pain psychologist. She is an Assistant Professor of Psychology at the Harvard Medical School and Associate Director of Psychological Services at the Boston Children's Hospital. She is founder and director of "The Comfort Ability," an international program that teaches evidence-based pain management skills to adolescents with chronic pain and their parents.

She will be visiting The Robinson Research Institute and the Women's and Children's Health Network in South Australia to educate researcher and clinicians on best evidence-based practices in pain management, and to establish links for a collaborative research program.



JONATHAN R. POLIMENI

Dr. Polimeni is an Assistant Professor of Radiology, Harvard Medical School and is a recognized expert in the use of functional MRI (fMRI) technology.

He will be visiting the University of Queensland to further an ongoing, NIH BRAIN Initiative funded collaboration with Prof Markus Barth and the team at the Centre for Advanced Imaging (CAI) at the University of Queensland.

A key aspect of the collaboration will be to use CAI's unique fMRI equipment configuration to conduct matching-parallel studies on mouse and human brains, thereby obtaining key insights into mapping out fine-scale structures of the functional architecture of the human brain.



PROF. PHILIP HOGG

Professor Hogg is the Head of the ACRF Centenary Cancer Research Centre and the Sydney Catalyst Chair in Translational Cancer Research at The University of Sydney Centenary Institute. His research focuses on how certain chemical modification of key proteins can influence their interaction with the immune system. This work has led to a potential new cancer diagnostic and a therapeutic drug, both of which are in clinical testing.

Prof. Hogg will be visiting 2017 Australia-Harvard Fellow, Prof Bruce Furie to progress their collaboration towards better understanding the immune system's complement system, and how it can be controlled. These awards take to 74 the total number of Australia-Harvard Fellowships granted since the program's inception in 2004. Harvard Club of Australia Foundation congratulates these 2019 recipients and offers heartfelt thanks to our volunteers involved in selecting, monitoring and administering the program.

Success stories of Australia-Harvard Fellowships

Australia-Harvard Fellowship is all about scientific collaboration between Australia and Harvard. From the start, we intended our A-HF awards should seed, rather than finance, such collaboration, and that, in allocating priority as between inbound and outbound working visits, A-HF should prefer the former. Its overall objective - to expand the mutual research network, benefiting both Harvard's and Australia's science communities.

A-HF PROMOTES NUCLEAR MEDICINE BREAKTHROUGHS

There can hardly be a better example of our program's success than a Fellowship we awarded in 2013 which has since cascaded into a wide-ranging exchange of ideas and practical outcomes. The topic is medical imaging, and in particular its most advanced technology, Positron Emission Tomography (PET/CT & MR), particularly its use in the early detection and management of cancer. It involved an associate professor and physicist from Sydney Uni who was already an expert in motion correction — that is, methods of retaining high-resolution images even though a patient's tissues may be moving involuntarily.


Roger Fulton, from University of Sydney's Brain and Mind research centre, had previously worked at the UN alongside one of Harvard's leading radiology specialists. Now he sought A-HF funding to help bring him to Australia. That's how **Georges El Fakhri**, Professor of Radiology at Harvard Medical School and Mass General Hospital, Boston, was afforded the opportunity to begin his Australian collaborations in 2013. The following year, we awarded Roger his own Fellowship for a return visit, thus cementing the research connections that inspired today's successes.

In the six years since, the collaborators' list of achievements and rewards has burgeoned. Georges and his Harvard team have joined Roger and Prof. Michael Kassiou (School of Chemistry, USyd) on an ARC Discovery project using novel 'awake-imaging' methods to gain new insights into the effects of anaesthetics on brain function and repair. In close collaboration with the Harvard group, a team from the School of Physics (led by Prof. Zdenka Kuncic and Dr Yaser Gholami) has developed and patented a ground-breaking radioactive nano-particle that can be injected into the body of a cancer patient, where it targets and kills cancer cells. The nano-particle can also be imaged with the new hybrid PET/MR imaging technique to confirm its accumulation in the tumour. This collaboration received a major boost when Zdenka was able to visit Georges' lab with the support of an A-H Fellowship in 2017. A further collaboration led by Prof. Steven Meikle (Health Sciences, USyd) is developing new improved PET kinetic modelling methods to detect the tiny releases of dopamine in the brains of rats in response to learning and other behavioural tasks. There have also been benefits for Australian students. Exciting projects and opportunities for exchanges have been made available to PhD students, and through his appointment as an Honorary Professor in Health Sciences, Georges has provided students at Master's level with outstanding recorded lectures on PET/MR applications and motion correction techniques in which his lab is a world leader.

As for our two A-H Fellows, Prof. El Fakhri became the endowed Nathaniel & Diana Alpert Professor of Radiology and recently received the prestigious Edward J. Hoffman Award in USA which honours those who have made outstanding contributions to nuclear medicine research and education. And Dr Fulton is now the Chair of the IEEE Nuclear Medical Imaging Sciences Council and the Conjoint Professor of Medical and Preclinical Imaging at USyd and Westmead Hospital. Our congratulations to them both.



PROFESSOR PAUL D. ALLEN, (AUSTRALIA-HARVARD FELLOW) HELPS NSW COUNTRY MEDICOS

Harvard Club's Australia-Harvard Fellowship often brings beneficial rewards in unexpected ways. Take the case of **Paul D. Allen**, Professor of Anaesthesia at Harvard Medical School. In 2012, we awarded him a Fellowship to come to Newcastle Uni's HMRI. for a collaboration aimed at helping **Laureate Professor Paul Foster**, Director of the Priority Research Centre for Healthy Lungs, identify new approaches to the treatment of steroid-resistant asthma.

Although his work there related to asthma research, Club member and A-HF selector **Dr Sue Morey, AM**, noted that Paul Allen was a world expert on Malignant Hyperthermia. It's a genetic

disorder that can cause death through exposure of susceptible people to anaesthetics. From her work in public health, Sue knew of a large number of such people in Lithgow, NSW, a country town with a total population of 21,000.

At Sue's initiative, Paul agreed to visit Lithgow. He met with medical students from the Rural Clinical School there and gave a lecture that was attended by a large number of health professionals from Lithgow and surrounding towns as well as susceptible family members. Beyond that, he advised the Clinical School on, and participated in, a research project and still continues to provide advice when requested.

A visiting Harvard professor is big news in a small country town, so his visits and continuing interest certainly provides a boost to the Rural Clinical School and to the local community.

2019 NON-PROFIT FELLOWSHIPS

The Non-Profit Fellowships were established in 2001 to bring enhanced leadership skills to the Australian non-profit sector; enable leaders to examine their mission, develop new strategies and improve the effectiveness of their organisation; and benefit the Australian community generally.

The Non-Profit Fellowships of A\$12,500 are funded by Bill and Lea Ferris. They enable two Fellows selected from the non-profit sector Australia-wide to attend the renowned Harvard Business School course titled "Strategic Perspectives in Non Profit Management" (SPNM) which is held each year in July.

Nominees must be the head of a non-profit organisation who has the potential to have a significant impact in the non-profit sector, and who meets various additional criteria.

Applicants may be nominated by an HCA member, a past Non-Profit Fellow or the Chairman of their organisation. Applicants may also self-nominate but must nominate a referee.

The Program Leader is Past President Lisa George. We thank Lisa and her selection panel, Anita Kumar, Tony Massaro, Patrick Regan, and Ben Sebel and Sam Sayers of the Australian Scholarships Foundation which assisted in the administration and short listing of applicants.

The awards were presented at the annual Non-Profit Lunch on May 27th, 2019, hosted by Macquarie Bank, and presented by Sam Meers AO, founding director of the Nelson Meers Foundation.



The 2019 winners are;

Karen Crouch, Chief Executive Officer, Anglicare Southern Queensland

Anglicare Southern Queensland is one of the oldest & largest providers of social services in the state, including disability and aged care, foster & kinship care, mental health counselling & intervention services, and finally crisis & transitional housing to women & children at risk of homelessness.

The organisation is in the midst of large changes due to the introduction of the National Disability Insurance Scheme and the Royal Commission into Aged Care. Karen seeks to review the strategic direction of the organisation in light of these changes on the horizon and respond effectively. Specifically, she is keen to transform the organisation to be more 'customer-centric', establish partnerships and create a high-performing organisation.

We saw several applications from this sector, and Karen's application and interview demonstrated a great willingness to embrace the change for the benefit of their clients.

Karen began her career as a Registered Nurse and has been with the organisation for over 10 years. She has been CEO for 6 years.

Matt Davis, National Director, Salvos Stores

The Salvos Stores is the wholly owned social enterprise subsidiary of the Salvation Army. Its unique contribution to the mission of the Salvos is to provide communities with retail experiences that enable social and environmental impact. The national network of 330 retail sites generates much-needed support for Salvation Army programs by serving over 200,000 customers per week, employing 12,000 staff and volunteers and recycling over 30,000 tonnes of donations from the community that might otherwise have been destined for landfill.

Matt presented quite a unique challenge to take to Harvard- one related to waste reduction & 'textile sustainability' associated with the wares in their stores and the current 'fast fashion' movement. He seeks some new strategic perspectives on these issues, not just from Harvard but also some other organisations he's identified to visit in the US that do this well.

Matt has been in this role for 3 years and also Chairs the industry body here in Australia so will seek to share these learnings more broadly.

2018 SIR JAMES WOLFENSOHN PUBLIC SERVICE SCHOLARSHIPS

The Sir James Wolfensohn Public Service scholarship was established in 2012 with the financial support of the former chairman of the World Bank; Patron and Past President of the Harvard club of Australia, Sir James Wolfensohn. It was established to promote the development and delivery of good public policy. There have been 21 scholars to date including those selected for 2018/19. Each of the candidates has been chosen on the basis of their potential to contribute to the benefit of Australian society. Many of the previous scholars have advanced in their careers to senior roles in State and Federal government.

The 2018 recipients of the Sir James Wolfensohn Public Service Scholarship are;

- Richard Bolt, Secretary, Department of Economic Development, Jobs, Transports and Resources in Victoria
- Rebecca McGarrity, Executive Director Social Policy, Queensland Department of Premier and Cabinet
- Damon Rees, CEO, Service NSW and
- Darren Foster, Director General, WA Department of Premier and Cabinet

The scholarships will allow Mr. Bolt, Ms. McGarrity, Mr. Rees and Mr. Foster to undertake executive education programs at Harvard University's John F. Kennedy School of Government in 2018 or 2019.

Mr. Bolt's chosen course is Leadership for the 21stCentury: Chaos, Conflict and Courage, Ms. McGarrity's chosen course is Driving Government Performance: Leadership Strategies that Produce Results, Mr. Rees's chosen course is Senior Managers in Government and Mr. Foster's course is also Senior Management in Government.

The four recipients were chosen from a wide field of candidates, all nominated by a Commonwealth, state or territory department or agency head. A shortlist of candidates was interviewed by a panel of Harvard University alumni comprising Naomi Flutter (Westfarmers), Nick Whitlam (Port Authority of NSW) and Peter Thompson (the Australia and New Zealand School of Government).



2019 HCA EDUCATION SCHOLARSHIPS

David Gonski, the guest speaker at our 2012 AGM, challenged us to "put principals on a pedestal". As a consequence of this challenge, former HCA President, Patrick Regan EdM'06, initiated this transformative scholarship program to send outstanding public school principals from around Australia to the Harvard School of Education to undertake a week long professional leadership development program.

The Public Education Foundation, and Teachers Mutual Bank along with our support, has subsequently enabled 22 Australian public school principals to attend these professional development courses at the Harvard Graduate School of Education.

These Scholarships have developed a high profile in the education sector. The Principals Program taught at Harvard has a high level of participation by Australian principals which has encouraged Harvard GSE to attempt their first course outside the USA. We are now bringing the Harvard Principals Program to Australia so that many more of the 10,000 school principals in Australia and 2,500 school principals in New Zealand can gain the benefit of this world class program for school leaders.

Since 2016, our involvement in the HCA Education Scholarship has been managed by Ricky Campbell-Allen EDM'10. Scholarships are awarded to early to mid-career principals who demonstrate significant leadership impact in their school and a commitment to public education.

The 2019 Public Education Foundation Scholarships to Harvard were won by;

- Karen Duncan, Harrisdale Primary School (WA) Teachers Mutual Bank Principals Scholarship
- Ann Caro, Lithgow High School Harvard Club of Australia Principals Scholarship Recipient
- Jesmond Zammit, Gorokan Primary School Public Education Foundation Principals Scholarship Recipient

Department of Education Director General Lisa Rodgers said Karen Duncan was an impressive leader who invested in all of her teachers to ensure every child was progressing in their learning and achieving their best.

"Karen's leadership, focus on education research and her commitment to keeping students at the heart of everything she does has seen Harrisdale Primary School skyrocket in popularity in the past four years since it opened - she has had a real impact on the learning and opportunities for local kids."



The 2018 Public Education Foundation Scholarships to Harvard were won by;

- James Kozlowski, Endeavour Sports High School, NSW
- Paul McDermott, Blue Haven Public School, NSW
- Jennifer Parrett, James Fallon High School, NSW
- Hamish Woudsma, Banksia Road Public School, NSW

Each Principals Scholarship is valued at approximately \$16,000 and includes program tuition for one of two prestigious Harvard Graduate School of Education programs: Improving Schools: The Art of Leadership or Leadership: An Evolving Vision.

SUPPORTING INDIGENOUS EDUCATION

We have changed the focus of our Indigenous scholarship to support the forthcoming Principals Centre in Australia. This is in recognition of the pivotal role played by Principals in transforming the lives of students and their communities. This scholarship will now be offered by the Aurora Education Foundation to bolster leadership both among indigenous Principals and Principals in secondary schools with significant indigenous enrolment.

Aurora in its formative period focussed on overseas post graduate study opportunities for indigenous Australians. The small pool of indigenous students qualified for overseas study opportunities has caused Aurora to work on the need to improve the aspiration of indigenous students all the way from primary school, through high school, into university and subsequently into post graduate study.

In 2019 we are supporting a school Principal identified by Aurora to attend the Principals Program at Harvard with an investment of \$15,000. The winner of this scholarship is **Everal Eaton**, Principal of Southern River College in WA who will attend the Principals program at the Harvard Graduate School of Education in 2019. Additionally, we have donated \$10,000 in 2019 and will commit \$25,000 in 2020 to support scholarships to the Principals Centre in Australia to enable indigenous Principals or Principals who are from regional and remote parts of Australia with a high proportion of indigenous students in their school.

Until 2019 we have supported postgraduate study by indigenous Australians at Harvard, and short course leadership programs to Indigenous community leaders. **Kathleen Jackson**, a Wiradjuri woman from Gulgong in NSW is in her last year of a six-year doctoral program at Harvard. Kathleen wants to help youth reclaim their autonomy and resist succumbing to negative stereotypes. To do this she believes it is important to have indigenous academics throughout university disciplines, not just within Indigenous Studies departments.

Charles Prouse graduated with a Master of Public Administration from Harvard in 2017. He is chairman of the Australian Indigenous Leadership Centre, has been on the Board of the Benevolent Society and a delegate for the National Congress of Australia's First Peoples. He is currently working with Lendlease in their Indigenous Supplier Diversity initiative.

We are represented in selection panels by Lisa George MPP'06, and Tim Goodwin LLM'12, the inaugural Roberta Sykes Harvard Club Scholar. The Chair of RSIEF is Peter Waters LLM'87 who is providing the leadership to change the focus of our support towards the Principals Centre in Australia.

The Harvard Club has a long history of supporting Indigenous scholars including Noel "Bilyana" Blomeley a 1992 R.G. Menzies Scholar who completed an EdM at Harvard, and more recently Selwyn Button a 2017 Wolfensohn scholar.

CLIVE GARD SCHOLARSHIP

The Clive Gard Scholarship is named in honour of our long time Club Administrator who was instrumental in successfully operating our Program for Leaders until 2014, contributing several million dollars to the endowment funds for our scholarship programs. The scholarship is available to club members, in mid-career, to attend the HCA Program for Leaders. The winner is selected by the Club President and executive in June each year.

The 2018 winner was Sarah Tesar, MPP'16 who has been active in organising events for Young Members. This scholarship is a valuable benefit of membership and is a strong reason to maintain your membership of HCA.
