

Minutes of the Forty-eighth Annual General Meeting of the Harvard Club of Australia held on Thursday, 17 June 2010 at the Union, Universities & Schools Club, 25 Bent Street Sydney.

Present

The total attendance was 64, consisting of Councillors, members and Club Guests.

Australia Address

The 2010 Annual General Meeting and Australia Address was delivered by Professor Warren McFarlan. Professor McFarlan earned his AB from Harvard University in 1959, and his MBA and DBA from the Harvard Business School in 1961 and 1965 respectively.

He has had a significant role in introducing materials on Management Information Systems to all major programs at the Harvard Business School since the first course on the subject was offered in 1962. He has been a long-time teacher in the Advanced Management Program: International Senior Managers Program, Delivering Information Services Program, and several of the Social Sector programs.

He teaches currently in the First Year Financial Reporting and Control course as well as in several short Executive Education programs. He is co-chair of the Senior Executives Program for China.

2010-2011

It is my great pleasure to present to you my first report as President of the Harvard Club of Australia. With the support of a committed Council and an engaged membership, your Club has excelled in delivering on its goals of:

- providing members with the opportunity to regularly meet and socialise with fellow club members;
- furthering the learning of club members; and
- promoting Harvard University in Australia and assisting Australians wishing to study there.

Events

Highlights from this year's events were many, and it is great to see that so many club members are taking the opportunity to meet with fellow graduates at our events. During the year we built a closer relationship with the alumni clubs of other US universities, most notably Yale, Columbia and Stanford; and through this can offer a broader list of events to our members.

A combined event with the US Ambassador, Jeffrey Bleich as speaker and light entertainment by the Din and Tonics was our first and most popular event post last year's AGM.

Annabel Crabb, ABC's political commentator gave a very entertaining presentation on the Federal election and the 'horse trading' between the parties following the outcome, where neither block gained majority in their own right.

Champagne and diamonds at Fairfax and Roberts was an educational evening, where we were invited behind the scenes to learn about diamonds through the whole process from selection, polishing and setting into beautiful masterpieces. The participants gained a deeper understanding of the four 'C's: Colour, Clarity, Cut and Carat, in time for the Christmas season.

Christmas drinks at our home was well attended and included a video shoot, wishing the Harvard Club of France 'Merry Christmas' on their anniversary.

The Vice Provost of Harvard University, Professor Jorge Dominguez visited Australia and gave Club members an insight into the changes that are taking place at Harvard to continuously adopt to the changing requirements for higher education and to maintain Harvard's leadership as the premier educational institution.

Our 11th annual Nonprofit Awards luncheon was well attended as always, with Tony Berg MBA'70 giving the keynote speech, pointing out the often unrecognised value of the time committed by volunteers in nonprofit organisations.

A night at Sydney Theatre was as entertaining as promised. We enjoyed 'The White Brigade', by the Russian author Bulgakov, describing events in the Ukraine at the time of the Russian revolution. The Director, Andrew Upton, introduced the play to us before the performance and some of the cast joined us afterwards for a drink together with the theatre's Artistic Director Cate Blanchett.

Menzies Scholarship

The Menzies Scholarship is funded by contributions from Harvard Alumni and by the Menzies Foundation and is jointly administered by the Harvard Club of Australia, the Australian National University and the Menzies Foundation.

Scholars are chosen on the basis of their potential for making a significant contribution to Australia and their intellectual ability, intellectual qualities, and breadth of vision. This year's scholars are part of the vanquard of Australian talent that attends Harvard.

Julia Smith has been admitted to the Harvard School of Education to study international education policy evaluation and innovation. Originally from country Victoria where she excelled at sport and played flute, Julia went on to be a leader at both Mannix and Queens Colleges in Melbourne before graduating from Monash with a Bachelor of Arts (First Class Honours, Human Geography and Politics double major).

In her spare time she set up her own nonprofit organisation entitled Help Educate Children to establish two primary schools in India. She has travelled widely in Africa and Asia, including to the Philippines as an Australian Youth Ambassador, and has worked for several years with local government in Camberwell leading sustainable transportation strategy.

President's Report cont.

Her passion is to improve access to education at the local level using private sector models and through community and government collaboration, particularly addressing the opportunity gap between Indigenous and non-Indigenous Australians and perhaps extending this expertise into international community development.

Luke Raffin is heading to the Harvard Kennedy School to study economic development policy. Also from a country town where he was his school's dux and best all-rounder, Luke became a Victorian Young Australian of the Year and a Centenary Medalist noted for his public speaking and representation of rural youth. From Queen's College he graduated from the University of Melbourne in 2006 with a Bachelor of Arts (First Class Honours) and Bachelor of Law (Hons).

Since then, he has spent a year with Freehills and three years with the Boston Consulting Group where he is currently a Senior Associate. Amongst other activities, Luke has worked in rural Vietnam and at the Cape York Institute for Policy and Leadership. He recently led a team in creating the Indigenous Capital Fund, a venture philanthropy fund providing access to private capital to small enterprises in remote Australia with success measured by job creation.

He sees his future in tackling inter-generational disadvantage through the application of both private and public models of economic growth in regional and remote communities in Australia or as an Australian representative in a multilateral organization such as the World Bank.

Angela Lopes has won a place at Harvard Business School where she will study an MBA. Hailing from Sydney, Angela is a University of Sydney Medalist with a Bachelor of Engineering (First Class Honours, Aeronautical and Robotics) and Bachelor of Science (Advanced).

A keen soccer and touch footy player with four years diverse experience at management consultancy Port Jackson Partners, Angela is fluent in Portugese and has spent time teaching English in the favelas of Rio de Janeiro for an NGO.

Post-Harvard, she sees herself returning to Australia to develop our sustainable energy consumption technologies before taking such expertise into the developing world, most likely in South America. This third Menzies Scholarship to Harvard Business School was enabled by a substantial donation from Harvard Club (Melbourne) member Anthony Burgess, who has set a precedent upon which the Club will be building in future years.

I would like to thank the Menzies selection committee for their role in administering the scholarship and selecting the scholars. The members of this year's committee were Jim Fox, Kim Rubenstein and Suiwah Leung from the ANU; Edwina Menzies from the Menzies Foundation; and Michelle Patterson, Charles Irwin and Alice Hill from the HCA.

The Menzies scholarship was the very first initiative of the Harvard Club of Australia and, according to Club Co-Founder Jim Wolfensohn, it provided the impetus for the foundation of the club. Its continued success is a tribute to the generosity and energy of Harvard alumni.

Roberta Sykes Harvard Club Scholarship

The Roberta Sykes Indigenous Education Foundation and the Harvard Club of Australia (HCA) have selected lawyer Tim Goodwin as the inaugural Roberta Sykes Harvard Club Scholar. Tim will commence an LLM (Master of Laws) at Harvard in September 2011.

This Scholarship was formed in honour of Roberta Sykes (1943–2010), an Australian poet and author, and an activist in Indigenous affairs, who graduated from Harvard with a PhD in 1984. As a result of her own experiences in struggling to obtain adequate funding to complete her studies at Harvard, it became part of her life's work to encourage and support Indigenous Australians to realise their dreams for further education.

The Roberta Sykes Harvard Club Scholarship is for talented Indigenous Australians who have potential to become leaders in both their field of study and in their communities. It is co-funded by HCA and is part of the Club's program, together with the RG Menzies Scholarship, to give outstanding Australians an opportunity to undertake postgraduate studies at Harvard.

Tim Goodwin is a worthy recipient of the inaugural Scholarship. After graduating from ANU in 2007 with a Bachelor of Laws with First Class Honours he worked with Professor Mick Dodson as a research assistant at the National Centre for Indigenous Studies and the United National Permanent Forum on Indigenous Issues.

From 2008 to 2010 he was a Judge's Associate in the Federal Court of Australia and a member of the Steering Committee that established the National Congress of Australia's First Peoples. Currently he is practising as a lawyer with Allens Arthur Robinson.

As part of his LLM at Harvard, Tim plans to examine how the Australian constitutional system might recognise a legally-binding agreement between Indigenous and non-Indigenous Australians.

When he returns to Australia, he plans to work as a barrister and his ambition is eventually, to become a judge. He also wants to inspire young Indigenous Australians to realise they can succeed in any field, at any institution, anywhere.

Nonprofit Fellowship

Thanks to the generosity of Bill and Lea Ferris, and the energy and capability of Ted Blamey, the Club celebrated the 11th Year of the Nonprofit Fellowship Program.

The Club was able to award three Nonprofit Fellowships in 2011. Two of the Fellowships were funded through the generosity of Bill and Lea Ferris, with the third made possible due to the support of the HBS Hansjoerg Wyss Fund for Social Enterprise, the YWCA NSW and the Harvard Club of Australia Foundation.

The 2011 Fellowships were awarded to Rory Jeffes, Managing Director, Sydney Symphony; Catriona Barry, CEO Special Olympics Australia; Ian Trust, Chairman and Executive Director, Wunan. All three fellows attended Strategic Perspectives in Nonprofit Management (SPNM) the annual strategy course for senior nonprofit executives held at HBS.

The Fellowships were awarded at the annual Nonprofit Luncheon on Thursday, 16 June 2011 by US Consul General Niels Marquardt with the Nonprofit Leadership Address by Tony Berg AM, Executive Director. Gresham Partners.

Chairman of the 2011 HCA NPF Committee, Mr. Ted Blamey, was assisted in the selection process by Tony Massaro, Tony Thirlwell, Lisa George and Patrick Regan.

Leadership Programs

The 2011 Leadership Program, titled 'Building Leadership Capabilities' was held on 7-12 August at The Novotel Sydney Manly Pacific. This program was conducted by HBS Professors Rohit Deshpande and Joshua Margolis.

The HCA Nonprofit Workshop was again held following the Leadership Program. The two HBS professors were joined in presenting the workshop by Professor Melinda Muth. The Nonprofit Workshop has become an important development activity for many Australian nonprofits who send members of their executive team each year.

The success of the Leadership Program and the Nonprofit Workshop is due in large part to the able management of Clive Gard and the team at Anderson Knight, and the assistance of Ted Blamey in the design and development of the Nonprofit Workshop.

Negotiation Workshop

The Club held its first negotiation workshop, 'Capturing the Power of Negotiation' in September, with Harvard Professor Daniel Shapiro. Dan is the Founder and Director of the Harvard International Negotiation Program and he is Chair of the World Economic Forum Global Agenda Council on Negotiation and Conflict Resolution. The workshop was fully booked with 43 participants, who enjoyed Dan's dynamic presentation of negotiating techniques and his unique insights into the emotional side of negotiations.



Monday Club

The Harvard Monday Club provides an opportunity for members to listen to the views of prominent Australian thinkers and achievers at informal Club luncheons. In 2010 and 2011 we listened to Professor Rodney Smith from the University of Sydney about what the 2010 Federal Election meant to Australians; Nick Stace CEO of Choice magazine; David Chesterman AM and David Kaunitz talk about the expanding role of Emergency Architects in Australia due to regional and local disasters; and Stephen Blanks discussed some of the consequences of Australia's refugee policy.

The Harvard Club of Australia Foundation / HCA Philanthropy

During the year we have restructured the HCA Foundation to comply with the changes in legislation: from Private Prescribed Fund to Private Ancillary Fund. The major changes for PAF from PPF are: the trustees must be corporations; the Accumulation Plan is replaced by an annual 5% minimum distribution requirement; PAFs must have a formal Investment Plan; and the annual audit must be in compliance with the Guidelines as well as the Financial Statements.

The Foundation was renamed HCA Philanthropy with a new board with Past President Chris Smith MBA'77 as Chairman. The Directors are: Past President Melinda Muth MBA'81, Philip Hartog MBA'81, the President and the Treasurer of the Club as ex officio directors. Clive Gard AMP'78 was appointed Secretary. The funds of HCA Philanthropy continue to be managed by Perpetual Trustees.

Schools and Scholarships Committee

Sarah Strasser led a dedicated team of members who interviewed a number of high school students as part of their application process to Harvard College. College graduates who would like to join the interviewing team should contact Sarah or the President.

 $\textbf{Professor Richard L Stevens}, \textit{PhD, Dept. Med. At HMS; and Division of Rheumatology, } \textit{Immunology and Allergy} \ \text{at Brigham \& Women's Hospital}.$

Professor Stevens is a world leader in studying an immune cell known as the 'mast cell' (MC), with a special focus on 'inflammatory bowel disease' (IBD) for which there is no long term cure. He is collaborating with **Professor Steven A Krilis**, MB BS UNSW, George Hospital, and with **Professor Paul Foster** at University of Newcastle. Having recently discovered that MCs and their tryptase mediators play key roles in a mouse model of IBD, their research is aimed at understanding the biology involved in specified medical conditions. Professor Stevens will be based at UNSW for a six month sabbatical from February to August 2010.

Assistant Professor Ali Khademhosseini, *PhD (MIT)*, *Dept. of Med. At HMS; also Div. of Health Sciences & Technology (HST)* at MIT, Assoc Bio-engineer at Brigham & Women's Hospital.

Ali's field is tissue engineering, focussing on micro-scale techniques in applications using biodegradable biomaterials such as polymers including synthetic and natural hydro-gels. His collaborator will be Associate Professor Fariba Dehghani, PhD (UNSW), Director of Postgraduate studies, School of Chemical and Bio-molecular Engineering, University of Sydney. Their overall aim is to develop long term collaboration between USyd and Harvard/MIT, and to underpin future substantial research grants. Several papers are already in preparation. Ali will visit for a month in late January and again in June 2010.

 $\textbf{Dr James Macklin,} \ Director \ of \ Collections \ \& \ Informatics \ and \ \textbf{Dr Paul J Morris}, \ Biodiversity \ Informatics \ Manager, \ HU \ Herbaria.$

Their topic is Biodiversity Informatics. They have an ongoing collaboration with ANU/CSIRO and Australian National Herbarium Centre for Biodiversity Research (CBR), specifically with **Drs Greg Whitbread** and **Jim Croft** at CSIRO/ANU. Their visit to ANU is aimed at advancing the International Plant Names Index (**IPNI**), an ongoing collaboration between HU's Herbaria and Australian National Herbarium in ACT, to continue their work in helping develop the IPNI, to test and prototype available technologies, and to prepare a technical implementation proposal of international significance for consideration by the Harvard – Kew Gardens – Australian IPNI management team.



Professor Jonathan B Losos, PhD (UCal. Berkeley), M & P Lerner Professor for the Study of Latin America, HU, Curator of Herpetology, Museum of Comparative Zoology.

This highly awarded academic will conduct research here on evolutionary diversification of agamids, a family that includes crocodiles. His goal is to address the question: are there general patterns of evolutionary diversification that apply to disparate groups evolving in different parts of the world? Or are the contingencies of history so great that every group follows its own evolutionary path? His collaborators are **Professor Rick Shine** FAA, Professor of Evolutionary Biology, ARC Federation Fellow, and **Dr Mike Thompson**, School of Biological Sciences, University of Sydney. Professor Losos will spend four months in Australia from September to December 2010, based in Sydney but will collect specimens in the far north, and visit Australian and Victorian museums and several other universities.

Professor John Quackenbush, PhD (UCLA), Professor of Biostatistics and Computational Biology and Professor of Cancer Biology, Dana-Farber Cancer Institute, and Professor of Computational Biology and Bioinformatics, Department of Biostatistics, Harvard School of Public Health.

His topic is the study of cell networks and cell differentiation, building models to help understand how cells transition from one state to another, as in development (egg to daughter cells) and diseases, eg cancer – normal cells transition to tumours. His principal collaborator is **Dr Christine Wells**, National Centre for Adult Stem Cell Research and Eskitis Institute for Cell and Molecular Therapies at Griffith University, Queensland. Also Professor **Emma Whitelaw** (QIMR, Brisbane) and **Louise Ryan** (CSIRO, Sydney). Over his four month sabbatical June to August 2010, Prof Quackenbush will utilise Dr Wells' existing database of olfactory stem cells, induce them to differentiate into a predetermined variety of cells, then build predictive models to understand the transitions from one state to another. Thenanalyse these systems to identify the core pathways and create models that include stochastic elements believed to have wide application in basic and translational research. They will incorporate ideas borrowed from theoretical quantum physics "to model the way in which cells explore the collection of possible state space trajectories that [may] improve our ability to predict responses to cellular perturbations". Results are to be published in several scientific and methodology papers. He will be based in Brisbane but travel to Sydney, Melbourne, and elsewhere to visit other nominated collaborators who have sought meetings.


